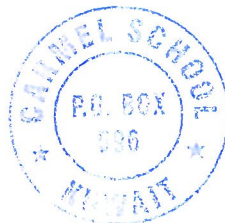

13. That the school will not coerce any student / parent to buy books / stationary / uniform from any particular shop.

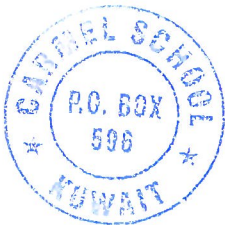
14. That the school shall strive to make efforts for conservation of environment.

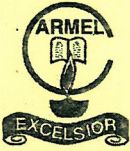

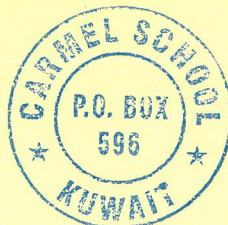
